
Powerful **Browse** and **Search** options support simple navigation through all content.

BROWSE


- Choose a **Browse** option found within the tool bar in the middle of the page.

- Select one of the **Search Term Hits** to be taken to the page your search was found in.


SAVE AND SHARE TOOLS


- The saving and sharing tools are found in the tool bar at the top of the page.
